



## California Mattress Recycling Program for Mattress Retailers

California's Used Mattress Recovery & Recycling Act requires the mattress industry to create a recycling program for mattresses and box springs used and discarded in the state.

The new law requires retailers to collect the recycling fee and offer customers the option to have a used mattress picked up, at no additional cost, when a new mattress is delivered. Taking advantage of MRC's no-cost recycling services is voluntary.

The Mattress Recycling Council (MRC) is a non-profit organization established by the mattress industry and certified by CalRecycle to plan and manage the California mattress recycling program known as Bye Bye Mattress.

As of December 30, 2015, retailers and other businesses selling mattresses began collecting a recycling fee on each mattress and box spring that is sold to California consumers and large volume users. These fees are remitted to MRC and used to recycle mattresses and combat illegal dumping.

### Benefits of Participating

- **Participating retailers no longer incur mattress recycling costs.** MRC uses the collected recycling fees to pay for recycling mattresses.
- **Recycling mattresses conserves natural resources and benefits the environment.** Program participants divert mattresses from landfills and allow materials like fiber, foam, steel and wood to be made into other useful products.

### What MRC Provides

- No-cost mattress drop off at an MRC contracted recycling facility
- Program promotional materials

### Participation Requirements

- Only mattresses collected from California consumers are eligible
- Make your own delivery arrangements with an MRC contracted recycling facility

### Which items are accepted and not accepted by the program?

**Most mattresses and box springs discarded by California retailers are eligible for the recycling program. Mattresses from out of state stores are ineligible.**

We are unable to accept:

- Severely damaged, wet, twisted, frozen or soiled mattresses or box springs
- Items infested with bed bugs
- Mattress pads or toppers
- Sleeping bags
- Pillows
- Car beds
- Juvenile products such as carriages, baskets, bassinets, dressing tables, strollers, and playpens or their pads
- Infant carriers, lounge pads, or crib bumpers
- Water beds or camping-style air mattresses
- Fold-out sofa beds
- Futons and furniture

# Frequently Asked Questions

## Mattress Recycling Program & Take-Back Requirement

### Am I required to recycle mattresses through your program?

No. You may continue to discard mattresses through your established relationships.

### The law says retailers currently have to provide the option to have a used mattress picked up, at no additional cost, at the time a new mattress is delivered. Does this mean I have to collect any mattress regardless of its condition from my customer?

There are some exceptions to this requirement. First, common carriers are not required to take back any discarded units. Second, a retailer or third-party contractor, may refuse to take a used mattress if they determine it is contaminated and poses a risk to personnel, new products or equipment.

### Where can my customer find a list of mattress collection sites?

California residents may drop off mattresses at no cost at any MRC contracted collection site or recycling facility. These are listed in the recycling locator at [ByeByeMattress.com](http://ByeByeMattress.com).

### Where can I find a list of participating recycling facilities?

MRC has a contract with the following mattress recycling companies. You must contact them directly to schedule a delivery time for no-cost recycling of your mattresses.
