BACKGROUND

The <u>Mattress Recycling Council</u> California, LLC (MRC) is soliciting applications for Pilot Study(ies) to prevent or eradicate the illegal dumping of mattresses, box springs and futons (together referred to as "Mattresses") in communities identified as adversely impacted.

Based on the applications received in response to this solicitation, MRC intends to award funding to project(s) that will:

- (1) establish or improve education about existing Mattress collection channels (through no-cost retailer pickup and/or MRC drop-off sites)
- (2) establish or improve awareness or enforcement of illegal dumping laws for Mattresses
- (3) establish or improve Mattress drop-off programs
- (4) beautify the area of an illegal dump site to deter future dumping

The deadline for submitting completed applications is 5:00 PST Friday, November 17, 2023. <u>All Pilot Studies under the Illegally Dumped Mattresses Pilot Studies Program (hereby referred to as "Program")</u>, must be completed by December 31, 2024. An extension to this deadline may be granted under limited circumstances or on a per project basis.

Additional funding may be released based on the results of the Pilot Studies awarded under this Program.

Illegally dumped Mattress clean-up projects or Mattress collection events are not eligible. For those interested in undertaking this kind of MRC initiative, please visit MRC's collection site and event host webpage.

ELIGIBLE APPLICANTS

Program funding is limited to California-based entities that have either:

- Submitted data and participated in the MRC Illegally Dumped Mattress Collection Initiative (IDMCI) in 2022 or earlier; or
- Can provide at least one year of baseline data within the last three calendar years (2021, 2022 and/or 2023) identifying illegally dumped Mattresses collected out of the public right-of-way relevant to the proposed project area. The baseline data must be included with the application.

The final report must include data demonstrating how and if the Pilot Study(ies) reduced illegal dumping of Mattresses using baseline data from the IDMCI or the baseline data provided by awardee. MRC can provide the IDMCI baseline data to funding recipients. The awardee will receive a final report template for submission at the end of the project.

MRC will develop a case study summarizing the results based on the final report, which will require the awardee's involvement and a final review.

EXAMPLE OF ELIGIBLE PILOT STUDIES AND USE OF FUNDS

• Education/Outreach

O Community workshops, school programs or social media campaigns that educate and encourage residents, property managers and other entities to stop illegal Mattress dumping from multifamily housing complexes, university off-campus housing, community parks and/or encampments.

- o Programs that identify and tag illegally dumped items or hot spot areas with educational materials.
- Print or electronic collateral focused on education and outreach programs that discourage illegal dumping, including one-time marketing costs and/or promoting free bulky item collection programs and MRC's collection network. Projects that specifically address multilingual outreach are encouraged.
- o Implementing behavioral change strategies through multi-coordinated efforts with community leaders, local agencies or community partners.

Eradication

- o Mattress collection infrastructure placed in non-traditional locations or unincorporated areas that serve several communities.
- Improved collection access to environmental justice, rural and underserved communities.
- o Improved collection opportunities at targeted multifamily dwelling complexes
- O Beautification projects that deter illegally dumped units through the process of making visual improvements to a town, city, or urban area. Additional points may be awarded to projects focused in environmental justice (EJ) areas. EJ areas may also be described as a "disadvantaged communities" which are areas disproportionately affected by environmental pollution and other hazards that can lead to negative public health effects, exposure or environmental degradation.

• Enforcement

o Increasing overall security enhancement and hazard mitigation through procurement of surveillance equipment, signage, lighting or fencing to be installed in illegal dumping hot spots for Mattresses.

FUNDING

MRC has allocated up to \$100,000 in 2024 to fund Pilot Study(ies) through this Program. Payment and reporting terms are described on page 5. The total funding for all Pilot Studies will not exceed \$100,000. MRC reserves the right to allocate all funding at its discretion, which may include funding of multiple Pilot Studies to Applicants.

MRC will rank applications based on a score of 0-100, according to the following set of criteria. All scoring criteria are subject to revision by MRC.

GUIDELINES AND QUESTIONS

All applications must include the Letter of Transmittal (attached) as the cover page to the Application.

Applicants may use the template application provided by MRC or their own format. All applications must include the following:

- 1. A description of the Applicant's experience with illegal dumping mitigation and/or enforcement, education and outreach, research and/or similar projects.
- 2. A Pilot Study description that clearly outlines the impact and methods for measuring success, and justifies why the project will be effective in terms of:
 - a. Additional Mattresses that could be prevented from becoming illegally dumped
 - b. Improved awareness and enforcement of illegal dumping laws
 - c. Improved education around proper disposal of Mattresses
- 3. Historical baseline data of illegally dumped Mattresses that will be used for the analysis of this study. **Please provide as an attachment with the proposal**
- 4. A Pilot Study work plan and timeline for implementation
- 5. A Pilot Study budget, any matching funds from the Applicant (optional) and a clear request fora specific amount of funding
- 6. Quotes for equipment if equipment is being requested

Respondents not participating in MRC's Illegally Dumped Mattress Collection Initiative must be able to provide to MRC at least one year of baseline data identifying illegally dumped Mattresses collected out for the public right-of-way within the last three calendar years (2020, 2021 and/or 2022).

Completed Applications must be received via email no later than 5:00 PST Friday, November 17, 2023, to MRC at Tgrimes@mrc-us.org.

Comments and questions should also be emailed to MRC at <u>Tgrimes@mrc-us.org</u> no later than 5:00 PM PST on Friday, October 14, 2023. MRC will respond to all questions. Applications that do not follow the guidelines may not be considered.

Applicants should describe in detail any potential conflicts of interest with MRC leadership or employees, or former employment in the Mattress industry within their application.

Funding recipients must agree to MRC's Project Terms as well as complete regular reporting requirements that may include photos or other documentation. MRC will use Project documentation for annual CalRecycle reporting and marketing purposes. Confidential information must be clearly marked as such and may be subject to regulatory disclosure requirements of CalRecycle or other state entities. Awardees will be reimbursed for costs based on achieving Project milestones. Awardees may submit reimbursement requests monthly if the scope of work is complete for the period for which funds are requested. MRC assumes no liability or ownership for infrastructure or equipment purchased with MRC funding. Costs incurred before contract execution or after the end of the contract term are not eligible. Applicants must have all permits (if necessary) and approvals in place before funds are disbursed.

3. Submit one (1) electronic copy of your application, along with the Letter of

Transmittal in Microsoft Word or pdf, including all attachments and addendums. MRC will confirm receipt of each application. It is your responsibility to confirm MRC's receipt of your application.

- 4. An Applicant that is selected by MRC to provide services under a formal contract with MRC will be an independent contractor to MRC, and will not function as an agent, partner or employee of MRC. Nothing contained herein shall be construed as contemplating any relationship other than independent contractor. As such, the party under contract with MRC would be responsible for (i) making day-to-day and critical decisions regarding the undertaking, management and supervision of those activities; and (ii) achieving compliance with all applicable federal, state, local or other laws and regulations.
- 5. Under the Act, MRC has certain legal obligations to report to CalRecycle regarding the status and progress of the Program. This includes providing aggregate information furnished to MRC by Program Participants.
- 6. MRC intends to begin the contract term as early as January 2024.
- 7. By applying, you agree to be bound by your Application for 180 days or until a formal contract is negotiated.
- 8. Failure to comply with the terms and conditions specified in the RFP could lead to your response being considered non-responsive and ineligible for further consideration.
- 9. MRC shall not be obligated to disclose any information about the winning (or losing) Applications.

- 11. You acknowledge that MRC's decision whether to enter into a contract at the conclusion of this Application process will be at MRC's sole discretion.

 - **a.** A valid and current Certificate of Insurance or Proof of Self-Insurance Minimum limits include:
 - General Liability Coverage of not less than \$1 million per occurrence,
 \$2 million Aggregate.
 - Workers' Compensation Coverage as required by state law.
