# Funding for Illegally Dumped Mattress Pilot Studies

#### BACKGROUND

The <u>Mattress Recycling Council</u> California, LLC (MRC) is soliciting applications for pilot study(ies) to prevent or eradicate the illegal dumping of mattresses, box springs and futons (together referred to as mattresses) in communities identified as adversely impacted.

Based on the applications received in response to this solicitation, MRC intends to award funding to project(s) that will:

- (1) establish or improve education about existing mattress collection channels (through no-cost curbside pickup, retailer take-back, and/or MRC drop-off sites)
- (2) establish or improve awareness or enforcement of illegal dumping laws for mattresses
- (3) establish or improve mattress drop-off programs
- (4) beautify the area of an illegal dump site to deter future dumping.

The deadline for submitting completed applications is 5:00 PST Friday, November 15, 2024. <u>All projects under the Illegally Dumped Mattresses Pilot Studies program (hereby referred to as "Program"), must be completed by December 31, 2025. An extension to this deadline may be granted under limited circumstances or on a per project basis.</u>

Additional funding may be released based on the results of the studies awarded under this Program.

Illegally dumped mattress clean-up projects or mattress collection events are <u>not eligible</u>. For those interested in undertaking this kind of MRC initiative, please visit <u>MRC's collection site and event host webpage</u>.

#### **ELIGIBLE APPLICANTS**

Program funding is limited to California-based entities that have either:

- Submitted data and participation in the MRC Illegally Dumped Mattress Collection Initiative in calendar year(s) 2023 and/or 2024; or
- Can provide at least one year of baseline data from 2023 and/or 2024 identifying illegally dumped mattresses collected out of the public right-of-way relevant to the proposed project area. The baseline data must identify the location where the illegal dumping occurred.

The final report must include data demonstrating how and if the pilot reduced illegal mattress dumping using baseline data from the Illegally Dumped Mattress Collection Initiative or the baseline data provided by the awardee.

MRC can provide the IDMCI baseline data to funding recipients upon request. At the end of the project, the awardee will receive a final report template for submission.

MRC will develop a case study summarizing the pilot's results based on the final report, requiring the awardee's involvement and a final review.

#### EXAMPLES OF ELIGIBLE PROJECTS AND USE OF FUNDS

#### • Education/Outreach

o Educating single-family and multi-family residents about proper disposal options and the economic, environmental, and social implications of illegal dumping through social media campaigns, community workshops, or school programs.

#### • Eradication

- o Beautification projects that improve public spaces aesthetically to deter the illegal dumping of mattresses through visual improvements to a town, city, or urban area.
- o Improving access to proper disposal by establishing mattress collection infrastructure in:
  - Traditional or non-traditional locations, illegal dumping hot spots and/or low-income areas
  - Environmental justice, rural and/or underserved communities or neighborhoods.
  - Multifamily dwelling complexes.

#### • Enforcement

o Increasing overall security enhancement and illegal dumping mitigation through procurement and installment of surveillance equipment, signage, lighting and/or fencing in illegal dumping hot spots or areas with high rates of illegal dumping.

Additional points may be awarded to projects focused on environmental justice (EJ) areas. EJ areas may also be described as "disadvantaged communities," disproportionately affected by environmental pollution and other hazards that can lead to negative public health effects, exposure, or environmental degradation.

#### **FUNDING**

MRC has allocated up to \$100,000 in 2025 to fund a pilot study(ies) through this Program. Payment and reporting terms are described on page 5. Projects are limited to a maximum amount of \$100,000.

#### GUIDELINES AND QUESTIONS

All applications must include the Letter of Transmittal (attached) as the cover page to the Application.

Applicants may use the template application provided by MRC or their own format. All applications must include the following:

- 1. A description of the Applicant's experience with illegal dumping mitigation and/or enforcement, education and outreach, research and/or similar projects
- 2. A project description that clearly outlines the expected impact and methods for measuring success. The description should also justify the project's effectiveness in terms of:
  - a. The estimated number of additional mattresses prevented from becoming illegally dumped
  - b. Improved awareness and/or enforcement of illegal dumping mitigation strategies
  - c. Improved education on the proper disposal of mattresses
- 3. Historical baseline data of illegally dumped mattresses will be used for the comparative analysis at the end of this study. **Please attach the baseline data to the project proposal.**
- 4. A detailed project work plan and timeline for implementation

- 5. A project budget, any matching funds from the Applicant (optional), and a clear request for a specific amount of funding
- 6. Quotes for equipment if equipment is being requested

Applicants not participating in MRC's Illegally Dumped Mattress Collection Initiative must be able to provide MRC with at least one year of baseline data identifying illegally dumped mattresses collected out for the public right-of-way from calendar year 2023 and/or 2024.

Comments and questions should also be emailed to MRC at TGrimes@mrc-us.org no later than 5:00 PM PST on Friday, October 10, 2024. MRC will respond to all questions. Applications that do not follow the guidelines may not be considered.

Applicants should describe in detail any potential conflicts of interest with MRC leadership or employees or former employment in the mattress industry within their application.

Awardees must agree to MRC's Project Terms and complete regular reporting requirements that may include photos or other documentation. MRC will use project documentation for annual CalRecycle reporting and marketing purposes. Confidential information must be marked as such and may be subject to regulatory disclosure requirements of CalRecycle or other state entities. Awardees will be reimbursed for costs based on achieving project milestones. Awardees may submit reimbursement requests monthly if the scope of work is complete for the period for which funds are requested. MRC assumes no liability or ownership for infrastructure or equipment purchased with MRC funding. Costs incurred before contract execution or after the end of the contract term are not eligible. Awardees must have all permits (if necessary) and approvals before funds are disbursed.

- 3. Submit one (1) electronic copy of your application, along with the Letter of Transmittal in Microsoft Word or pdf, including all attachments and addendums. MRC will confirm receipt of each application. It is your responsibility to confirm MRC's receipt of your application.
- 4. An Applicant that is selected by MRC to provide services under a formal contract with MRC will be an independent contractor to MRC, and will not function as an agent, partner or employee of MRC. Nothing contained herein shall be construed as contemplating any relationship other than independent contractor. As such, the party under contract with MRC would be responsible for (i) making day-to-day and critical decisions regarding the undertaking, management and supervision of those activities; and (ii) achieving compliance with all applicable federal, state, local or other laws and regulations.

- 5. Under the Act, MRC has certain legal obligations to report to CalRecycle regarding the status and progress of the Program. This includes providing aggregate information furnished to MRC by Program Participants.

  - **b.** A valid and current Certificate of Insurance. Minimum limits include:
    - Commercial General Liability Insurance of not less than \$1 million per occurrence.
    - Workers' Compensation Coverage as required by state law.
